## Who We Are



### Spokane's Professional Contemporary Dance Company

Vytal Movement Dance is a nonprofit 501 c-3 arts organization dedicated to presenting quality concert dance in a variety of venues and providing professional performance and dance education opportunities to our community. We were founded in the summer of 2016 by Founding Director, Vincas Greene, and currently operate under the artistic direction of Lexie Powell. Our company is composed of 13 extensively trained dancers and is supported by a Board of Directors, all of whom volunteer their time and share a passion for our art and the important role it plays in the wellness of our Spokane community.

Throughout the year, Vytal Movement Dance presents full length dance concerts, offers community dance classes of varying levels, participates in performance and dance education outreach opportunities, provides a studio space for artists to create and host performances, and collaborates with dancers, musicians, and artists to create new works to showcase in and around Spokane.

In the past two years, we have presented 10 sold out performances and hosted over 100 community dance classes.

Our mission is to ENGAGE, EDUCATE, and ENCOURAGE the development of dance and arts in our community through positive action, performance and presentations, and community collaboration.

### A DANCE GALA

Last year, Vytal Movement Dance hosted our inaugural fundraising event, *Illuminate: A Dance Gala*.
